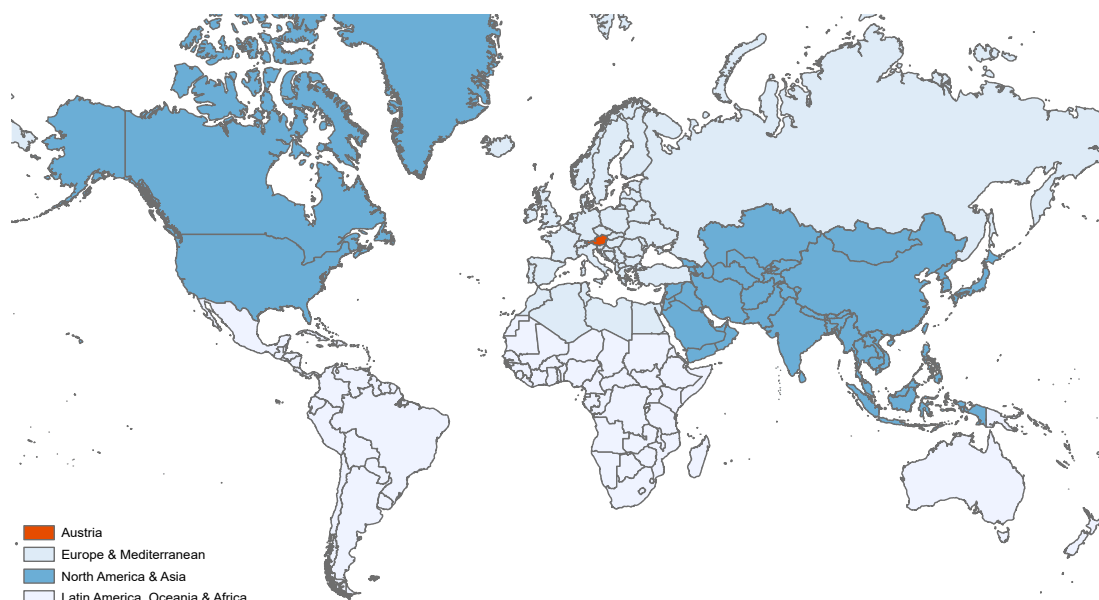
1. Please rename this form with the filename “LastFirst_CBA.pdf” replacing Last & First with your names
2. Attach your supporting documents in the order shown above to your bursary application form and save everything as a single PDF. If you are unable to merge your supporting materials with the application form, they may be uploaded separately as .pdf or .doc(x) files. Please name the supporting files “LastFirst_CV” and “LastFirst_Status” and indicate below that the materials were uploaded separately.

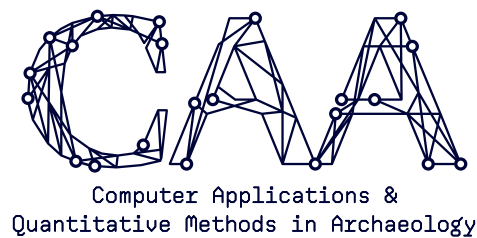

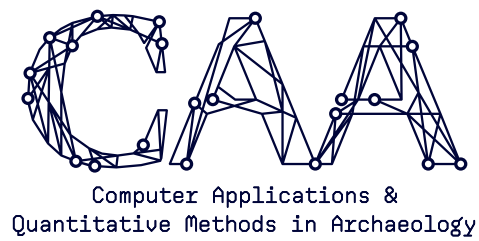

Instructions for Completing the Budget Form

1. Please estimate the travel expenses that you would like to be considered when evaluating your bursary application. Totals for each category may be rounded to whole amounts, if preferred. If your primary currency is euros, please enter all of your costs in the right column. If you will pay for some expenses, such as flights, in a currency besides the euro, please enter those in the column labelled Original Currency column, and **then convert them to euros in the right hand column**. Please also indicate what the original currency is in the column heading.
2. **Number of Days:** Please indicate the number of days you will be at the conference in order to estimate the cost of meals, which will be calculated at a rate of €30 per day. Each full day away from home may be counted as 1 day. A travel day that begins or ends at your home may be counted as a ½ day. Each applicant may include a maximum of 6 days of meal expenses in their budget.
3. **Conference Registration Fee:** Please enter the conference registration fee corresponding to your anticipated 2026 membership level in the right-hand column. If the registration has not opened at the time you are submitting your application, please leave the field blank. If you are unsure of your 2026 membership level, please visit the CAA 2026 Membership page for further information: <https://members.caa-international.org>. Please note that you must be a 2026 CAA member in order to register and attend the conference.
4. **Further Funding:** Please include the total amount for all confirmed or potential funding from other sources that will help support your travel expenses. Please explain in your statement the sources of all potential funding as well as what is guaranteed. Bursaries rarely cover all travel expenses, so applicants are strongly encouraged to seek out other funding to help with costs.
5. **Difference:** Please note that the anticipated expenses need to be equal to or greater than the bursary amount requested.

If you have listed an amount for Further Costs, such as a visa fee, please briefly explain these additional expenses.
